HOLLAND PATENT - Daniel V. "Dan" Ziobro, age 59, passed away unexpectedly on Monday, July 8, 2024, in the comfort and dignity of his home. At the time of his passing, he went on to his next home where he was welcomed by his son, Dan, Jr., and his parents who preceded him.

Dan was born in Utica on June 29, 1965, the son of the late Francis S., Sr. and Carmelina R. "Miss Carm" (Leone) Ziobro. In his youth, Dan was an accomplished boy scout under the guidance of his own father who was the leader of Troop 115. Dan learned many skills that would help later in life on family camping trips, keeping him and those he loved dry when it was wet and warm when it was cold. Dan went on to graduate from John F. Kennedy High School in 1983.

Dan married the former Becky Yeomans on May 13, 1989. When they met in 1983, he captured her heart with his smile, love of family, and the way he treated his mother. Becky immediately learned that Dan was a genuine, caring and supportive soul. They were soulmates and each knew that they would not have been able to accomplish life in the way they did without the other. Prior to starting their family, Dan and Becky enjoyed following The Grateful Dead on tours, enjoying the concerts, each other, the company, and seeing the country at each new venue.

Dan started working in the baking industry at the age of 16. He was fortunate enough to work with Don Colucci at Donato's Bakery. He then moved on to Salvatore's Bakery, then Star Bakery in East Utica, spent a little time at Price Chopper, and then ultimately went back to Salvatore's Bakery in Washington Mills.

Dan was an irreplaceable source of skill, know-how, and talent. He especially excelled as a Master Pastry Chef. In his spare time, Dan became the owner and operator of Above & Beyond Painting where he was able to turn another passion into a career. Those lucky enough to have partaken in Dan's wine making hobby know he could turn people who didn't like wine into wine enthusiasts.

Dan is survived by his "Baby Doll," Becky; sons, Ryan C. Ziobro and his wife Amanda, and Tyler V. Ziobro and his fiancée Laura Snyder; and a long list of grand pets. Also left to cherish his memory are his sister and brother-in-law, Marylourdes and Mark J.
