



## Mr. David M. D'Ambro, Ret. UFD

June 6, 1961 - December 24, 2024

UTICA – Mr. David M. D'Ambro, Ret. UFD, age 63, passed away on Christmas Eve, Tuesday, December 24, 2024, following a courageous battle with cancer. At the time of his passing, he was surrounded by the love and support of his family.

Born in Utica on June 6, 1961, David was the son of Carmen A. and Rosalie A. (LaBarbera) D'Ambro. He was a graduate of T.R. Proctor High School/Class of 1979.

David was proud of his role as a firefighter with the Utica Fire Department, a position for which he was well suited. Exemplifying humility, he cherished his work as a public servant, dedicating himself to his community until his retirement.

Most important to David was his family. He loved and respected his parents deeply, and held his relationships with his siblings, and nephews in the highest regard. With a quiet and unassuming nature, as well as a loyal heart, he was a devoted friend to many.

From a young age, David displayed artistic talents, creating exceptionally beautiful murals and drawings. A memory that he cherished most was learning the art of making wine with his father, a tradition that began when he

was a child. An animal lover, he could often be found walking his Dobermann Pinscher. He was also a meticulous landscaper, ensuring every flower had its place. David enjoyed hosting friends for gatherings where good food and great times were shared by all. The highlight of his time here on Earth was spending time with his family and friends.

A devout Catholic, David was a parishioner of St. Mary of Mt. Carmel/Blessed Sacrament Parish.

David is survived by his parents, Carmen and Rosalie; sisters and brothers-in-law, Roseann and Vincent Tutino, Christine and David Rosato, and Karen D'Ambro; and brother, Michael D'Ambro.
