



Mrs. Gayle Elaine (Frey) Taurisano

October 9, 1939 - March 20, 2025

NEW HARTFORD – Mrs. Gayle Elaine (Frey) Taurisano, age 85, passed away on Thursday, March 20, 2025, in the comfort and dignity of her home. At the time of her passing, her loving family was by her side.

Born in Utica on October 9, 1939, Gayle was the daughter of the late William M. and Arlene T. (Richards) Frey. A graduate of T.R. Proctor High School/Class of 1957, she later received her nursing license from St. Elizabeth School of Nursing.

Gayle was wed to Michael P. Taurisano on February 10, 1959. Their relationship began as high school sweethearts at the age of 14 and spanned 71 years, including 66 years of marriage.

She began her career in private duty nursing care, while raising five children. She then built her own business from the ground up at a time when female entrepreneurs were very rare. Beginning as a nursing registry that developed into a New York State Licensed Homecare Agency, Oxford Home Care Services has been the premier home healthcare agency in Oneida County for over 40 years. Upon her retirement at age 75, her eldest daughters, Laine and Tami, took over and maintained the standard that Gayle set.

Gayle was a true visionary, passing her work ethic and creativity on to her

children and grandchildren, who are all extremely proud of her entrepreneurial legacy.

Gayle's life revolved around the love and needs of her family, and her generosity was second to none. She was dignified, private, and reserved, and always displayed impeccable taste, style, and subtle wit. She was fondly known as "Mema" by her grandchildren and their friends.

Being of the Catholic faith, she was devoted to the Blessed Mother, praying the rosary twice each day. Christmas was especially important to her and her Christmas Eve celebrations have left a profound impact on the entire family.

Gayle is survived by her husband, Michael; children and their spouses, Laine and Sam Berardino, Tami and Michael Pfisterer, Michael V.
